As California's 60+ population increases by an average of 157,000 annually for the next seven years, Meals on Wheels programs across the state grapple with a widening disparity between existing funding and surging demand.Stagnant funding has resulted in a downward trend of overall ability to meet needs of the increasing older adult population growth. Since 2021, we have seen a 20.45% inflation on food costs. Inflation alone accounts for a reduction of 4.2 million meals. This does not account for statewide wait lists of unfunded meals, nor the growing demand that cannot be addressed without additional resources.
