

## **GOVERNOR'S BUDGET REVISION SEEKS TO CUT \$111 MILLION**

As California's 60+ population increases by an average of 157,000 annually for the next seven years, Meals on Wheels programs across the state grapple with a widening disparity between existing funding and surging demand. The proposed cut would result in an estimated 17.2 million fewer meals across California. This accounts for an annual reduction of 5.7 million meals without accounting for inflation, wait lists, unfunded meals, and a growing demand in which we cannot address across the state.



## **Growing Population**

By 2030, older adults will outnumber children for the first time in U.S. history. The Census Bureau predicts that by then, 21% of the population will be seniors, with 1 in 4 adults over 60 in California alone. This growth reflects the increasing need for topnotch services for seniors.



### **Funding Shortfall**

One in three programs in California currently has a waiting list, leaving seniors waiting an average of three months for meals. These cuts will make matters worse, resulting in more waitlists, greater hunger, and a higher number of malnutrition-related deaths among seniors who may lose their only consistent meal.



#### **Proven Solution**

Meals on Wheels keeps seniors healthy, independent, and out of costly institutional care, saving public funds. Expanding medically-supportive meal programs like Meals on Wheels nationwide could prevent 1.6 million hospitalizations, saving insurers \$13.6 billion annually.


